

Scout Shop Holiday Give Back Giveaway

Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. MANY WILL ENTER, BUT ONLY TWO WILL WIN!

1. Eligibility: The Scout Shop Holiday Give Back Giveaway (the “Promotion”) is open only to legal residents of the 50 United States and the District of Columbia, who are 13 years of age or older and reside in the U.S. at the time of entry. Void elsewhere and where prohibited by law. Employees, directors, officers, and contractors of the Boy Scouts of America (“Sponsor”), including its subsidiaries and affiliated companies, and the advertising, fulfillment, judging and promotion agencies involved in the development and administration of this Promotion (collectively, “Promotion Parties”), and their immediate family members (parent, child, sibling, and spouse of each) and those living in the same households of each are not eligible. No purchase necessary to enter or win.

2. Promotion Period: The Promotion begins at 12:01 a.m. Eastern Daylight Time (“EDT”) on November 12, 2019, and ends at 11:59 p.m. EDT, December 2, 2019 (the “Promotion Period”).

3. How to Enter: During the Promotion Period, go to scoutshop.org (“Website”) to locate the official entry form. Follow the on-screen instructions, complete all required registration fields and submit to enter. You (“Entrant”) must complete all required information. By entering this Promotion, the Entrant promises that: Entrants acknowledge and agree Sponsor has the right to display, perform, distribute, edit, adapt, modify, reproduce, promote and otherwise use any and all Entries in any manner it sees fit, and the right to sublicense the foregoing rights to third parties of Sponsor’s choice, including but not limited to this Promotion’s prize provider(s). Any Entry not in compliance with these Official Rules or not meeting Sponsor’s requirements will be disqualified.

4. Prize Drawing: On or about December 3, 2019, Sponsor will randomly select one (1) winner from among all eligible entries received during the Promotion Period.

5. Prizes, Approximate Retail Value (“ARV”) & Odds: The winner will receive one (1) Scout Shop gift card valued at \$100, redeemable at National Scout Shops and online at Scoutshop.org. Total approximate retail value (ARV) of Prizes in this Promotion is \$100.00. No substitution, cash redemption, or transfer of Prize is permitted except at Sponsor’s sole discretion. **SPONSOR MAY, IN ITS SOLE DISCRETION, MAY SUBSTITUTE A PRIZE WITH AN ALTERNATIVE PRIZE OF EQUAL OR GREATER VALUE.** All federal, state and local taxes and all other costs associated with acceptance or use of the Prize are the sole responsibility of the winners. 6. Winner Verification. The potential winners will be contacted by Sponsor via social media direct message to verify his/her their eligibility. The winner will be required to sign and submit an affidavit of eligibility and release of liability and a publicity release within 10 days of being contacted by Sponsor. If a potential winner is under the age of 18, then his or her parent or legal guardian must also sign all required winner verification documentation. If a potential winner cannot be contacted, the message is undeliverable or any information requested from the potential winner is not received by Sponsor within the specified 10-day period, then the potential winner will be disqualified and the Sponsor will, in its sole discretion, either choose an alternate winner or choose to not award the Prize.
