

2021 Win Your Wish List Holiday Sweepstakes

Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. MANY WILL ENTER, BUT ONLY ONE WILL WIN!

1. Eligibility: 2021 Win Your Wish List Sweepstakes (the “Promotion”) is open only to legal residents of the 50 United States and the District of Columbia, who are 13 years of age or older and reside in the U.S. at the time of entry. Void elsewhere and where prohibited by law. Employees, directors, officers, and contractors of the Boy Scouts of America (“Sponsor”), including its subsidiaries and affiliated companies, and the advertising, fulfillment, judging and promotion agencies involved in the development and administration of this Promotion (collectively, “Promotion Parties”), and their immediate family members (parent, child, sibling, and spouse of each) and those living in the same households of each are not eligible. No purchase necessary to enter or win.

2. Promotion Period: The Promotion begins at 12:01 a.m. Eastern Daylight Time (“EDT”) on November 30, 2021, and ends at 11:59 p.m. EDT, December 10, 2021 (the “Promotion Period”).

3. How to Enter: During the Promotion Period, go to scoutshop.org (“Website”) and login to (or create) your account. Then, create a Wish List comprised of products whose total aggregate retail value, as determined by the prices displayed on the Website at the time, does not exceed \$300.00 (a “Qualifying Wish List”), and then share your Qualifying Wish List with giveaway@scoutshop.org using the “Share Wish List” button. Each Qualifying Wish List so shared will constitute one Entry. Any Entry not in compliance with these Official Rules or not meeting Sponsor’s requirements, including any Wish List whose total value exceeds \$300.00, will be disqualified.

4. Prize Drawing: On or about December 13, 2021, Sponsor will randomly select one (1) winner from among all eligible Entries received during the Promotion Period.

5. Prizes, Approximate Retail Value (“ARV”) & Odds: The winner will receive the contents of his/her Wish List (valued at no more than \$300). No substitution, cash redemption, or transfer of Prize is permitted except at Sponsor’s sole discretion. **SPONSOR MAY, IN ITS SOLE DISCRETION, MAY SUBSTITUTE A PRIZE WITH AN ALTERNATIVE PRIZE OF EQUAL OR GREATER VALUE.** All federal, state and local taxes and all other costs associated with acceptance or use of the Prize are the sole responsibility of the winners. Arrangements for delivery of Prize will be performed after winner verification. Odds of winning Prize depend on the number of entries received.

6. Winner Verification. The potential winners will be contacted by Sponsor via email to verify his/her their eligibility. The winner will be required to sign and submit an affidavit of eligibility and release of liability and a publicity release within 10 days of being contacted by Sponsor. If a potential winner is under the age of 18, then his or her parent or legal guardian must also sign all required winner verification documentation. If a potential winner cannot be contacted, the message is undeliverable or any information requested from the potential winner is not received by Sponsor within the specified 10-day period, then the potential winner will be disqualified and the Sponsor will, in its sole discretion, either choose an alternate winner or choose to not award the Prize.

Notwithstanding the preceding sentence, Sponsor may disclose entrants’ information to one or more of Sponsor’s service providers for the purpose of enabling them to perform a business, professional, or technical support function for Sponsor.
